## DECLARATION OF FAY ARFA

I, Fay Arfa, state and declare as follows:

1. On April 5, 2008, the government filed a criminal complaint against Mr. Guo.
2. Mr. Guo qualified for the appointment of counsel pursuant to 18 U.S.C. § 3006A and, on April 7, 2008, the Court appointed a CJA panel attorney to represent him.
3. The family retained me to represent Mr. Guo and, on June 25, 2007, I substituted in as retained counsel to represent Zhi Yong Guo.
4. On July 27, 2009, after the jury found Mr. Guo guilty, the district court judge sentenced Mr. Guo to 60 months in federal prison, and ordered him to pay several fines, including a \$12,500 fine.
5. Mr. Guo's financial affidavit shows that he has no income and has been incarcerated for nearly a year and a half.
6. He is heavily in debt and owes more than \$150,000 with

no income or any means to pay the filing fees for an appeal.

7. Mr. Guo simply cannot afford to even pay the cost of providing himself or his dependents with the necessities of life let alone, any filing fees.
8. Mr. Guo lacks the financial resources to pay for filing his criminal appeal.
9. I have not been paid to handle Mr. Guo's appeal to the Ninth Circuit.
10. Mr. Guo is serving a 60 month sentence in federal prison.
